



# 4TRESS FARMS 3D Barrel Racing Jackpot



## RULES & GUIDELINES

The Teepee Creek Stampede Association will be hosting a 3D Barrel Racing Jackpot during our annual Stampede, July 13-15, 2018. This Jackpot is intended by the Stampede association for local ladies to complete at / during our event which has a very long history here in the community. It is intended for those ladies who are not eligible to compete in either the CPRA Pro rodeo or the Junior Rodeo. The following are some guidelines we would like to be within to for our event:

1. Date of Race – **Friday July 13, 2018 8am-12pm**

2. Name of Arena – Lyons Production Services Event Centre

3. Time: Warm Up – 7am-730am Start Time: 8 am SHARP .

a. There is a warm up area available outside the arena.

b. Arena time before the barrel race will be dependent upon time constraints.

c. You may warm up on the track, however there is to be **ABSOLUTELY NO loping circles on the track**. Straight lines only. Also, **No tying on the track**. This rule is put in place for the safety of the horses running on the track to prevent irregularities on the race track, please use respect and abide by this rule.

4. **3 CALL RULE**. You will be called 3 times, if you are not ready to run, you will forfeit your run & entry fees.

a. under special circumstances you may be moved to the bottom of the draw, this will be to the Teepee Creek Stampede and Teepee Creek Barrel Racing Committee's discretion.

- a. 1<sup>st</sup> – Championship Buckle by Usher Brand
- b. 2<sup>nd</sup> – Stirrups by Usher Brand
- c. 3<sup>rd</sup> – Knife by Usher Brand
- d. Payout dependent upon number of entries, as per ABRA guidelines (*Race is not ABRA Approved*)

**IMPORTANT:**

- e. Award Presentations will be at ½ HOUR after jackpot in the Lyons Production Services Event Centre. **YOU MUST BE IN ATTENDANCE AND IN WESTERN ATTIRE** to receive any prizes or monies OR IT WILL BE ROLLED TO NEXT PERSON. *The Stampede Association and Teepee Creek Barrel Racing Club will not be held responsible for delivery of prizes or money.*
- f. **ALL** contestants are asked to attend the award presentation (in western attire) for sponsor photos and to support your fellow competitors.

7. No peewee or junior categories as there is a junior rodeo happening before the jackpot where they may compete (15 and under). 16 AS OF JANUARY 1<sup>ST</sup>, 2018 ENTERS THE LADIES JACKPOT.

- a. Open Format, however, **NO CPRA or PRCA CARD HOLDERS of any kind are permitted to race in this jackpot.** They are free to enter the CPRA portion of the Teepee Creek Stampede Rodeo on July 13, 14 and 15, 2018 if they wish to compete at Teepee Creek.
- b. If you are eligible to compete in either the Junior rodeo (15 and under AS OF JANUARY 1, 2018) OR the Pro CPRA Rodeo at Teepee Creek, you are NOT eligible to run in this Jackpot.

8. 7/10 split.

**10. PRE-ENTRY SYSTEM**

- a. Must be entered (AND PAID) by 12:00 PM, **July 2, 2018.**
- b. ETRANSFER FEES TO [cassmcl@hotmail.com](mailto:cassmcl@hotmail.com) password jackpot. Please put your name in message part of etransfer so I know who the money is from. Send forms and cheque payable to Teepee Creek Barrel Racing to the above address (Theresa McLeod). **WAIVERS MUST** be signed and with all entry forms. If we do not receive a waiver with entry forms your entry is incomplete and will not be accepted.
- c. First PAID 100 entries will be accepted. Cheques can be made payable to "Teepee Creek Barrel Racing". There will be a \$50 charge on NSF checks received by The Teepee Creek Barrel Racing Association.
- d. Entries will not be reimbursed should you choose to turn out.
  - i. Only with a valid Veterinary or Doctors certificate will entry fees be reimbursed. It must be received by the Teepee Creek Barrel Racing NO later than July 11, 2018
- e. **Entry Fee of \$100.00 per Horse; \$100.00 pre-entry fee (Only send \$100.00 per horse to me as your entry fee. Entry to the rodeo is not included in this fee.**

f. Limited number of entries taken due to time constraints – will be filled on a first come / first served paid in full basis.

g. Should the maximum number of entries not be filled by the entry cut-off date. Late entries will be accepted until the max number of entries is met. A late fee of \$25 per entry will apply and will only be accepted until July 11 at 10pm. Late entries will be added to the bottom of the draw.

11. WESTERN ATTIRE IS REQUIRED INCLUDING HATS OR HELMETS.

12. Each contestant will get two runs. Best of two runs will count towards money and prizes.

13. Only clean runs will count; knocked barrels are a no-time.

14. All rider/horses must run in order of program.

15. Any questions or disputes which arise during the course of the event which are not covered by the above rules will be decided and settled by the committee whose decision is final.

16. Must be in good standing with the Teepee Creek Stampede Association in order to enter.

17. Changes, information, or cancellation will be posted on the Teepee Creek Stampede Website and / or Facebook page. [www.tpstampede.ca](http://www.tpstampede.ca) and the Teepee Creek Barrel Racing Facebook page.

18. WAIVER MUST accompany entry forms.
